OPERATING GRANTS PROVIDE BOTH PROJECT FUNDING AND OPERATING SUPPORT AT VARYING LEVELS TO MANY CULTURAL AND EDUCATIONAL ORGANIZATIONS IN THE ST. LOUIS AREA. OPERATING SUPPORT IS CATEGORIZED INTO THREE LEVELS BASED ON THE BUDGET SIZE OF AN ORGANIZATION.
